#### **General terms and conditions:**

- Engagement of manpower is purely time bound, non-regular and not against any sanctioned vacancy/ cadre strength/ post/ position; the service provisions for regular posts including reservations will not be applicable to the engagement. - ICAR-National Research Centre on Pig does not carry any kind of liability, job security etc. The selection is purely on contractual basis. Engagement shall automatically terminate without warranting any notice on

the part of the employer upon completion of the project. Unsatisfactory performance of the YP-II, SRF & JRF may lead to termination of services at the discretion of Competent Authority at any time during the project period.

3. YP-II working in the scheme is required to travel extensively and support the Principal Investigator to undertake the routine activities in the project related works and coordinate the activities with the entrepreneurs. They are required to show satisfactory performance of duties and maintain discipline as per the conduct and prevailing rules of ICAR/ institute concerned.  
Non maintenance of the discipline or failure to perform the duties assigned will make the YP-II liable for termination.
4. The position is purely temporary and will be filled on contractual basis till the termination of the scheme or as per the need, whichever is earlier. Duration of engagement can be curtailed / extended as per need and subject to performance of the candidate.
5. The above positions are purely on contractual basis subject to satisfactory performance. The selected candidate shall have no right/claim for regular appointment or absorption at ICAR/CARI at any point of time.
6. **The interested candidates with requisite qualification have to appear in the walk-in-interview with the application in standard format along with a copy of C.V (as per Annexure-I) and must bring his/her original copies with attested photo copies of all certificates including experience certificate, a recent passport size photograph at the time of interview, failing which the candidate will not be allowed to appear for the interview.**
7. Incomplete application/application received without Annexure-I, Annexure-II and without documents as mentioned under the list of enclosures of Annexure-I will not be accepted/considered and such application will be treated invalid.
8. Selected candidates will be informed about their selection by email/phone, for which the candidates are required to provide their email IDs and contact numbers positively in the application.
9. If the candidates are large in number, shortlisting will be done based on their qualifying academic performance as per the assessment criteria/written examination and only the shortlisted candidates will undergo a panel interview.
10. No TA/DA and official accommodations will be paid/provided for appearing in the interview.
11. Concealing of facts or canvassing in any form shall lead to cancellation of candidature. Decision of The Director, ICAR- National Research Centre on Pig will be final.
12. Person already in employment should submit “No Objection Certificate” from their present employer.
13. The candidate intending to appear in the Walk-in Interview, if any of his/her near or distant relative is an employee of the ICAR-NRCP, have to declare his/her name, designation, nature of duties, relationship, in advance, before the start of interview to the undersigned in the format provided in Annexure-II.
14. The selected candidates will have to submit medical fitness certificate and character certificate at the time of joining.
15. For leaving the contract in between the stipulated period, he/she shall have to give a minimum of one month notice in advance, to avoid disturbance of the project/Office work, failing which he/she will have to deposit one month salary with the employer.
16. His/her headquarters will be at ICAR-NRCP, Rani, Guwahati and he/she will work under the immediate administrative control of the CCPI/ Project In-Charge/ Head of Office of the said project/ scheme under the overall control of the Director, ICAR-NRCP, Rani, Guwahati. However, he/ she may be asked to go on tours anywhere in India to compile/ collect data required for the project.
17. The ICAR will not be liable to bear any expenditure on pension contribution/ leave salary contribution/ provident fund, ESI, medical insurance, etc.
18. The Director, ICAR-NRCP, Rani, Guwahati reserves the right to cancel/ postpone the interview without assigning any reason thereof.
